The Mission and Installation Contracting Command (MICC) U.S. Army Yuma Proving Ground (USAYPG), Arizona, intends to negotiate a firm-fixed price contract on a sole source basis with Immaculate Conception Church (ICC) 505 S. Ave B, Yuma, AZ 85364-2732 for Catholic Religious Services in support of the Chaplain located at USAYPG. The North American Industry Classification System (NAICS) code is 813110 with a standard size of \$7 million dollars. The contract will be for a one year period (01 October 2012 - 30 September 2013). The services consist of sixty-five worship services (includes sacrament of reconciliation), seventy-nine musical accompaniments, seven-four Confraternity Christian Doctrine (CCD), twenty-five sacramental instructions, one pre-lenten renewal mission (Tritium) and twelve administrative requirements. The Catholic Church divides communities into parishes based on geographic location. The Archdiocese of Tucson, who has parish oversight in this region, designated that USAYPG will fall under the direction of ICC which is home to the only Episcopal Vicar in the Parish.
